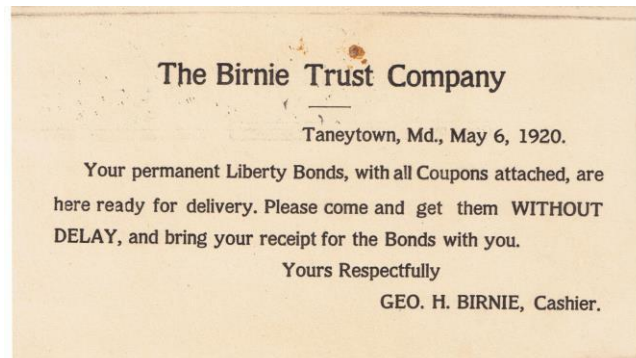


Taneytown, MD – Envelope 1918
